



# Addendum - Scottish Amendments to the Guidance on Contractual Issues Caused by Coronavirus

# Part 1 - General Considerations

# A. Impact of Coronavirus on the construction industry

- 1. Contractors working in Scotland should be aware that at the time of publication of this note (4 May 2020), the guidance for carrying out construction activities in Scotland is different to elsewhere in the UK. In Scotland, only essential construction works can be undertaken even if proper health and safety provisions are in place. Contractors should ensure that they comply at all times with any laws, regulations or guidance issued by the Scottish Government from time to time, as this position may change.
- 2. At the end of Paragraph 5, add the words "Force majeure".
- 3. At the end of Paragraph 6, add the words "Part 2, A.6. Part 3, A.5".

# D. Variations (see also JCT and NEC sections for specific guidance)

1. Change the title to: "D. Variations (see also SBCC and NEC sections for specific guidance)".

#### G. Materials

1. At the end of Paragraph 1, add the words "extension of time".

#### I. Public Contracts

- 1. Add in the words "(SPPN 01/20)", to the first line of paragraph 1, after the words "The Scottish government has issued a Scottish Procurement Policy Note".
- 2. Add in the words "(SPPN 02/20)", to the first line of paragraph 2, after the words "There is also a Scottish Procurement Policy Note".

#### Part 2 - JCT Contracts

1. At the end of the first paragraph, add the words "Appendix at Part 2".

#### **B. Health and Safety**

- 1. At the end of Paragraph 1, add the words "Clause 2.25.6.1".
- 2. At the end of Paragraph 2, add the words "Clause 2.25.6.1".

#### C. Price

- 1. After the words "In SBCC contracts where fluctuations options", add "(see SBCC fluctuations)" into paragraph one.
- 2. At the end of paragraph two (Variations), add the words "Time and Programme SBCC Contracts".

1. At the end of the second sentence, add the words "Appendix at Part 3".
